

Privacy Policy

Windgate Adventures recognizes the importance of maintaining the privacy of the Users of the Windgate Adventures Website. This policy provides an overview of the information Windgate Adventures collects, how that information can and cannot be used, and other important information relating to privacy issues. This Privacy Policy together with the Terms of Use govern your use of the Windgate Adventures Website. If you don't agree with either of those policies, you should not use the Website.

Information that You Provide and How Windgate Adventures Uses It

In order to receive newsletters or other communication, download content or use some restricted parts of our website, you may need to provide certain personally identifiable information (such as your name, email address, etc.).

We use personally identifiable information to operate the Windgate Adventures Website and to provide certain information you have requested. We may share your personally identifiable information with our affiliates or third parties which we hire to help us operate the Website, but in each case, those parties must process and/or handle the information in conformance with this Privacy Policy and can only use the information on our behalf. We also require that they implement reasonable security measures to protect against the loss, misuse or alteration of any information we make available to them.

You may receive email updates or postal mailings from Windgate Adventures about services that we offer that may be of interest to you. If you no longer wish to receive those communications, you can contact Windgate Adventures at info@windgateadventures.com to unsubscribe or you can reach us by phone or regular mail at the address and number set forth at the end of this policy.

We do not share your personally identifiable information with third parties to market their products and services, unless you specifically agree to receive those types of communications (commonly called "opting in").

Other Information that Windgate Adventures Collects and How Windgate Adventures Uses It

Windgate Adventures uses "cookies" (a cookie is a piece of information that the Windgate Adventures Website sends to your internet browser, and then your browser stores that information on your computer). Cookies help the Windgate Adventures website remember certain information, such as storing your preferences when you use the Website, having the Website remember your sessions, and to customize information you might see based on your interests. We typically uses two different kinds of cookies – session cookies are temporary and are erased after you close your browser. Persistent cookies remain after you close your browser, however, you can delete or disable this type of cookie by adjusting your preferences in the browser toolbar. Please be aware that if you disable all cookies, some of the functionality of the Windgate Adventures Website may not work properly.

We also use log files to record information that your browser sends to the Windgate Adventures Website. This includes things like your IP address, what pages you have viewed, the amount of time spent on pages, and other information. That information is logged anonymously – that is, it cannot be tied back specifically to your personally identifiable information, but is captured and analyzed on an aggregate basis. We use this aggregated information to track usage of the website, help improve the user experience of the Windgate Adventures Website, and to help create features and marketing opportunities based on analyzing the data.

Situations Where We May Need to Disclose Personally Identifiable Information

Windgate Adventures may need to disclose your personally identifiable (or non-personally identifiable) information in the following ways: (i) if we are required to do so by law, or in response to a court or administrative order, subpoena, search warrant or other legal process, (ii) to enforce the Windgate Adventures Terms of Use (iii) to protect the Windgate Adventures Website, and (iv) to protect the personal safety of our users or visitors.

Windgate Adventures employs reasonable technical, procedural and physical techniques to protect the information stored on our systems, so that it cannot be accessed, disclosed, altered or destroyed. We limit the personnel who have access to your personally identifiable information to only those who need the information in order to perform their jobs, such as customer service agents or technical staff. Despite our reasonable efforts, we cannot absolutely guarantee the security of your information.

Changes to this Privacy Policy

We may need to update or revise this policy over time so you should check the Windgate Adventures Website frequently to see recent changes. Unless stated otherwise, the current Privacy Policy applies to all information that we have about you and your account (you can determine the date of the current Privacy Policy went into effect by looking for the “date Last Modified” at the end of the policy). Minor changes will take effect as soon as they are posted, and any material changes will take effect within thirty (30) days of being posted.
